



## Privacy Policy for Intermap Technologies, Inc.

**Last updated: May 25, 2018 ("Effective Date")**

Intermap Technologies is the owner and operator of [www.intermap.com](http://www.intermap.com) and other websites (the "Websites"), as well as online platforms for various products ("Platforms"). By visiting the Websites, you are accepting the practices described in this policy ("Privacy Policy"). If you do not agree to this Privacy Policy, you must not access or use any Website or Platform or provide any information to Intermap. Intermap has created this policy in order to demonstrate our firm commitment to privacy, establish certain guidelines for your use of the Websites and Platforms, and describe our practice for collecting, processing, maintaining, protecting, and disclosing information. The following discloses our information gathering and dissemination practices for the Websites.

### Changes to the Privacy Policy

As Intermap's products and services change from time to time, this Privacy Policy is expected to change as well. We reserve the right to amend the Privacy Policy at any time, for any reason. The date of the last revision to the Privacy Policy will be indicated by the "Effective Date" at the top of this page.

### Information provided to Intermap

Intermap may collect several types of information from and about you, including:

- Personally identifiable information, such as name, postal address, email address, telephone number, company and title, each classified as "Personal Information".
- Information about your internet connection, the equipment you use to access the Website or Platforms and usage details.
- Financial and payment information related to orders placed on a Website or through a Platform.

Intermap collects this information directly from you when you provide it to us or automatically as you navigate through a Website or Platform.

The information collected on or through Websites or Platforms or through other interactions with Intermap, may include:

- Information that you provide by filling in forms on a Website, including reporting a problem with a Website or Platform.
- Work history and related employment information gathered from you in response to any employment opportunities or job postings.
- Correspondence information, such as name, phone numbers, company and email addresses.
- Details of commercial transactions you carry out through a Website or Platform.
- Your search queries on a Website or Platform and usage/analytics of the same.
- Any product information, including imagery, that you view or download via our Platforms.
- Suggestions, questions, information, material or other content, collectively "Feedback", posted on a Website or Platform.

### Intermap's lawful basis to collect and process Personal Information.

Intermap collects and processes Personal Information only where there is a lawful basis to do so. Your consent, fulfillment of the performance of a contract or a legitimate interest, such as providing a product or service to you, protecting our network, monitoring Website and Platform performance or processing and evaluating job applications, all provide a lawful basis for collecting and processing Personal Information.

### **Information collected automatically (e.g. cookies)**

Through the use of various automatic data collection technologies, we may place or recognize a unique "cookie" on your browser. Cookies are small files placed on the hard drives of visitors to the Websites. The cookies reflect identifying information about each user and retain certain non-identifying information about the user's use of the Websites or Platforms. These cookies are accessible to Intermap and its third party advertisers as users browse the Websites. Most Internet browsers are initially set to accept cookies. Users are always free to decline cookies if their browser permits; however, it is possible that some parts of the Websites, such as the areas where access is limited to registered users, will not function properly if the user's cookies are disabled. You may occasionally receive cookies from our advertisers or business partners who offer services through, or advertise on, the Websites. We do not control these cookies, and these cookies are not subject to our privacy policies.

### **Archiving and Preservation of Information**

We archive all information, including personal information, you provide in the course of using the Websites and Platforms. We store that information on servers that are controlled by us or by third parties who have agreed to comply with our commitments made under this Privacy Policy. Archived information will not ordinarily be erased unless and until your entire account with any of the Intermap Websites is deleted, and even then we may retain, but will not continue to use for any purpose, some or all of your information on back-up files.

### **Security and Identity**

The Websites and Platforms have security measures in place to protect against the loss, misuse and alteration of the information under our control; however, all security is subject to possible circumvention, and we cannot and do not provide any guarantees regarding the effectiveness of the security we employ or our ability to prevent third parties, acting unlawfully, from obtaining information that you provide to us. For example, you are responsible for maintaining the confidentiality of your registration number and password, and you are responsible for all uses of your registration number or password, and any and all related charges, whether or not authorized by you.

### **Children under the age of 13 may not give us their Personal Information.**

We do not knowingly collect Personal Information from children under 13. If you are under 13, do not provide any information on or through a Website or Platform or through any features/registration, including your name, address, telephone number, email address or any screen name or user name you may use. If we learn we have collected or received Personal Information from a child under 13 without verification of parental consent, we will delete that information. ### **Intermap uses your information for a variety of purposes.**

We use information that we collect about you or that you provide to us, including any Personal Information:

- To present a Website or Platform and its contents to you.
- To personalize your experience on a Website or Platform.
- To promote products and services to you.
- To provide you with information, products or services that you request from us.
- To support your use of Websites, Platforms and other products and services.
- To develop and improve products and services.
- To fulfill any other purpose for which you provide it, such as job applicant evaluation.
- To enforce our rights arising from any contracts entered into between you and us, including for billing and collection.
- To notify you about changes to a Website, Platform or any products or services we offer or provide through it.
- To comply with any court order, law or legal process.
- If we believe disclosure is necessary or appropriate to protect our rights, property, or safety of us, our customers or others.

#### **Disclosure of information to a Third Party**

We may disclose information we collect, including Personal Information, as follows:

- To Intermap subsidiaries, affiliates, distributors, or resellers.
- To contractors, service providers, or other third parties used to support Intermap products and services and who are bound by contractual obligations to privacy protection provisions no less restrictive than the Privacy Policy.
- To any other entity or organization with your consent.

We may disclose aggregated information from or about you without restriction as long as this information does not personally identify you. We will not sell your Personal Information to a third party.

You may revoke your consent permitting the sharing of your Personal Information at any time by following the instructions on the message you receive or contacting [privacy@intermap.com](mailto:privacy@intermap.com). If for some reason we are unable to honor your request, we will provide an explanation as to why your request has been denied.

#### **Intermap may transfer Personal Information across borders in accordance with applicable law.**

We may transfer your Personal Information to several different countries. We implement legally compliant and appropriate safeguards to ensure the lawfulness and security of these transfers.

#### **Intermap may keep your information for so long as necessary.**

We keep your information, including Personal Information, for so long as necessary to perform the purpose for which it was collected. We may retain information for longer, even after you stop using our products and services, to the extent reasonably necessary to comply with our legal obligations, maintain security, enforce our terms, resolve disputes and prevent fraud and abuse.

#### **Your rights regarding Personal Information.**

You are entitled to exercise the following rights at any time by contacting [privacy@intermap.com](mailto:privacy@intermap.com):

- You may request access to your Personal Information as well as details on the processing of your Personal Information, such as what is collected and who may receive it. If we are unable to provide access within a reasonable timeframe, we will provide you with a date when the information will be provided.
- You may request changes or corrections to your Personal Information where it may be inaccurate or incomplete. We may not be able to accommodate a request to change information if we believe the change would violate any law or legal requirement, cause the information to be incorrect or if such information is needed to continue to provide products and/or services to you. Some information, such as Feedback posted by you for public viewing on a Website, may remain viewable in cached and archived pages or might have been copied or stored by other Website users.
- You may request restriction or erasure of your Personal Information if you feel the processing is inaccurate, unlawful, unnecessary or where you have objected to the processing. We may not be able to delete your Personal Information without also deleting your user account. We may reject your request if such request would interfere with our legitimate interest in processing your Personal Information.
- You may have the right to receive a copy of your Personal Information as well as a right to have it transferred to another data controller.
- You may withdraw your consent to processing for marketing purposes.

If you feel the processing of your Personal Information is unlawful, you are entitled to file a complaint with the appropriate supervisory authority for the protection of your Personal Information.

#### **Canada Anti-Spam Law**

Intermap complies with the Canada Anti-Spam Law. Non-ABA members or associates who provide us a Canadian mailing address will not receive unauthorized Commercial Electronic Messages (as defined under the Canada Anti-Spam Law) unless these individuals have “opted-in” to receive Commercial Electronic Messages.

#### **California resident additional privacy rights.**

California Civil Code Section §1798.83 permits users of the Website that are California residents to request certain information regarding our disclosure of personal information to third parties for their direct marketing purposes.
